8. Pre-bid meeting will be held in *Office of the Municipal Executive, Rajdevi Municipality, Rautahat* at 11:00 hrs on 26th Jan 2022 (12/10/2078).
9. electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egpon or before 12:00 hrs of 11th Feb 2022 (2078/10/28 B.S.). Late bids will be rejected and not opened. The bids will be opened physically and electronically at 14:00 hours on 11th Feb 2022 (2078/10/28) in the presence of the bidders' representatives who choose to attend in person at *Rajdevi Municipality, Rautahat*.
10. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
11. Bids shall be valid for the period as mentioned in the table above after the deadline for Bid submission and Bid security shall be 30 days more as bid validity period.
12. *Office of the Municipal Executive, Rajdevi Municipality, Rautahat* reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
13. If the last date of pre-bid meeting, purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

Note: 1. For EGP/09/RM/N/NCB/N/078-079 only, the Machines, required as per bid document must be owned by the contractor and must submit the ownership evidence document while bidding. Non Submission of Such documents may lead to the disqualification for the technical Capability.

2. For EGP/09/RM/N/NCB/N/078-079 only, the bidder must submit the recommendation letter about site visit from concerned office along with site visit report in bid document which have been prepared after visiting the proposed site.
